2.COMPOSITION / INFORMATION ON INGREDIENTS

Caustic Pearls	less than 5%
SLES	less than 5%
Soda Ash - Sodium Carbonate	less than 5%
Citric Acid / Sulphonic Acid	less than 5%
Salt / Dye / Methyl Paraben	less than 5%
Water	Upto 100%

The above formulations exhibit good foaming characteristics both in terms of flash foam and foam stability. This formulation includes ingredients that ensure mildness and a soft feel on the hands.

3.HAZARDS IDENTIFICATION

This product is NOT CLASSIFIED dangerous in accordance to chemical regulations.

However as with all industrial and institutional chemical products good housekeeping should prevail with regard to section 4-16 inclusive handling, storage, first aid, disposal etc.

However the following advisory precautions are to be considered. Readily biodegradable unlikely to accumulate in aquatic environment. Skin should be thoroughly dried after use.

4.FIRST AID MEASURES – POSSIBLE HAZARD

- a)** Skin: No hazard expected.
- b)** Eyes: irrigate the eye for at least 10 minutes with fresh water or use an eyewash.
